Texas Cooperative Extension:

Walk Across Texas (Fort Bend County) – 507 participants. The average age of participants was 39.9 years. The net present value per female is \$49.391.00; the total net present value for health care costs savings for females is \$4,235,151.00; total net present value for wages lost is \$210,103.00 which equals a total net present value for females of \$4,445,254.00. The net present value per male is \$44, 718.00; the total net present value for health care costs savings for males is \$1.046.381.00; the total net present value for wages lost is \$117.681.00 all of which total a net present value for males at \$1,164.063.00. Total economic impact is \$5,609,318.00.

Walk Across Texas (Brazoria County) - 256 participants. The average age of the participants was 38.66. The estimated economic impact health cost savings for 2003 is \$332,470.00. The long run economic impact (Net Present Value -NPV) is \$2,917,942.00. Net present value reflects the value of the future health care cost savings and reduction in lost wages from age 51 through 65 and for lost wages through life expectancy for health care costs. Results of pre and post screenings provided by Angleton Danbury Medical Center were provided to participating individuals and showed a 7% reduction in body fat composition and 20% reduction in total cholesterol.
